- **Emergency Care:** In the event of an injury or illness where I cannot be reached, I authorize the **Victoria Men's Golf Club** staff or representatives to seek and authorize professional medical treatment, including ambulance care if reasonably required, and I am responsible for all related costs.

6. Liability Waiver & Equipment

- **Release of Liability:**

- I agree to freely accept and fully assume all risks, dangers, and hazards associated with my child's participation.
- I release and forever discharge **Victoria Men's Golf Club**, its officers, directors and members (the "Released Parties") from any liability from any and all claims, demands, actions, damages, losses, costs, and causes of action, in contract, tort, statute, or otherwise, that I or my child now have or may in future have arising out of or in any way related to my child's participation, including any claim arising from the ordinary negligence of a Released Party, but excluding only claims arising from the gross negligence or wilful misconduct of a Released Party where such exclusion is not permitted by law.
- Agree to indemnify and hold harmless the Released Parties from any and all claims, demands, actions, damages, losses, liabilities, costs, and expenses (including legal fees) brought by any person arising out of or connected with my child's participation, my child's failure to follow rules or laws, or my own failure to comply with this Agreement.
- I understand this Release and Indemnity is intended to be as broad and inclusive as permitted by the laws of Alberta, and if any part is held invalid, the remainder continues in full force and effect.

- **Equipment:** I understand the minor is responsible for their own golf clubs and gear. The Club is not responsible for lost or stolen items.

7. Transportation

I understand VMGC and its members are not responsible for my child's transportation to or from the course or for ensuring pick up after play. I am solely responsible for safe and timely transportation and pick up. I understand that VMGC does not provide continuous supervision, and my child may be unsupervised at times.
